Piedmont Public Schools ARP ESSER III Budget Plan

Update FY23:

Piedmont Public Schools will continue school in a traditional format for the 2022-2023 school year. We will provide and promote safe and healthy practices and protocols in order to help keep our student and staff safe. We ask parents to not send students to school if they are sick. This includes fever, cough, sore throat, shortness of breath, nausea, vomiting or diarrhea. Students may return to school when they are symptom-free without medication aid for 24 hours.

- School visitors are allowed in the building for school-related reasons.
- Meals will no longer be free for all students. Traditional meals, a la carte items and additional items will require payments or be charged to the student's account. <u>Click here</u> to see meal pricing.
- Traditional bus transportation will be provided. <u>Click here</u> to access our route transportation software.
- The social and emotional well-being of our students is as important as their academic learning. Our site counselors and licensed mental behavioral specialists are available to help our student and families with community resources.

Overview:

COVID-19 and its variants have brought many challenges to Piedmont Public Schools, but we are proud to have implemented safety measures that allowed us to keep our schools open during the 2021-2022 school year, with intermittent school closures for distance learning. Stakeholder engagement is a regular and proactive part of our planning. Soliciting and incorporating public input into our ESSER III plan is required by the Oklahoma State Department of Education. In consultation with stakeholders, the following strategies/items have been identified as needs for Piedmont Public Schools. The consultation team will continue to meet to review the needs of the district and utilize the ARP funds to meet the needs of our district to prepare, prevent, and respond to academic impact due to COVID-19.

Part 1: Prevention and Mitigation Strategies

Piedmont Public Schools will use ESSER III funds to implement prevention and mitigation strategies that are consistent with the CDC and local health department on reopening schools to safely operate. In consultation with stakeholders and through completed surveys the following strategies/items have been identified as needs for Piedmont Public Schools.

<u>Expenditure</u>	Strategy/Items for Prevention & Mitigation
Supplies for maintaining a safe environment	Mask, gloves, safety system upgrade
Cleaning Supplies & Equipment	Cleaning supplies to sanitize and clean the facilities to help prevent the spread of COVID-19
Professional Development	Professional Development for staff to assist in tracking positive cases and tracking quarantine numbers
Upgrade Projects	Upgrades to the ventilation systems

Part 2: Strategies for Addressing Learning Loss

Piedmont Public Schools will reserve 20% of the ARP ESSER III funds allocated to the district in order to address the academic impact of lost instructional time through the implementation of evidence-based intervention. The ideas that resulted included: Professional Behavioral Health Specialist, instructional resources with included technology components, and intervention programs to address instructional gaps and identify student needs. Piedmont Public Schools has set aside \$241,250.72 to help address the academic impact of lost instructional time. We consider our most vulnerable population to be economically disadvantaged students, students who were greater impacted by the pandemic such as distance learning due to quarantines, positive cases of Covid19, and families who suffered severe illnesses including deaths. We are purchasing Screencastify to provide enhanced virtual learning opportunities for our students who were forced to transition to virtual learning. We are purchasing devices for all students in kindergarten through 12th grade. We are purchasing Mystery

Science for an online platform to supplement and enhance our in-person curriculum. We are purchasing Learning A-Z for our elementary students to assist in reading instruction. Learning A-Z will also be utilized by our reading specialist and elementary reading interventionists. We are purchasing EdPuzzle to provide interactive video lessons for our students and monitor progress through our learning management system. EdPuzzle was instrumental during our A/B schedule in which students experienced a combination of distance learning and in-person learning.

Part 3: Other ARP ESSER III Expenditures

Piedmont Public Schools plan to utilize ARP ESSER III funds to prepare, prevent, and respond to the COVID-19 impact on our district. In consultation with various stakeholders, the district will utilize funds for the following:

- 1. Purchase of two additional yellow route buses to allow for social distancing
- 2. Purchase of two school vehicles to deliver meals and virtual learning packets
- 3. Purchase of district technology infrastructure equipment
- 4. Technology updates-Chromebooks, iPads, or MacBooks
- 5. Other activities necessary to maintain the operation and continuity of services

Part 4: Ensuring Most Vulnerable Populations Unique Needs Are Addressed

Piedmont Public Schools plans to utilize ARP ESSER III funds to prepare, prevent, and respond to the COVID-19 impact on our district. In consultation with various stakeholder, the district will utilize funds for the following:

1. Additional counseling staff to provide services to all students including those most vulnerable population. Also, counselors will provide additional support and help identify any additional needs of the vulnerable population. We consider our most vulnerable population to be economically disadvantaged students, students who were greater impacted by the pandemic such as distance learning due to quarantines, positive cases of Covid19, and families who suffered severe illnesses including deaths. The curriculum used by the district at all grade levels can easily be modified to allow for various backgrounds that will be more suited to address the needs of the vulnerable population.



Select the FIVE areas that should be the top priority of the PPS ESSER III funds designation:


